- One article from each section, selected by the judges, will be published in the reputable ISI international journal.
- Selected works will be printed in a specialized book of the event with publishing permission and ISBN registration (a 25% discount will be applied for all participants on book purchases).
- The fee for evaluating each work is 10,000,000 IRR (7,000,000 IRR for students).
- Submitted works will remain the property of the conference organizers while preserving the name of the artist, and the organizers will have the right to use and publish the work. Participants, by attending the conference, accept these terms and will not claim otherwise.
- Some selected articles will be published in the form of poster presentations and displayed in the gallery.
- Accepted articles will be published in the specialized journal of the Sports Law Association.
